Bits and Pieces

- **Membership Meeting** Our next 4th-Wednesday-of the-month meeting is Wednesday, <u>April</u> 25th 7:00 pm at American Heritage Federal Credit Union—Red Lion & Jamison Road.
- City Spring Cleanup Saturday, April 7, 10:00 to 2:00 PM While the GBCL regularly organizes neighborhood cleanups, the city conducts its own city-wide cleanup every year. Volunteers will meet on Northeast Avenue at Grant Ave to give the railroad trestle area more TLC. Keeping Bustleton free of litter and visually appealing helps reduce crime and keeps our property values stable. And it begins with the area right outside our own front door.
- Many Home Projects Need Permits With the spring, comes spring home projects. It is recommended to check city requirements for your project, often fences and decks. The Zoning Code currently states: fences at the <u>front</u> of a dwelling may be up to 3 ½ feet in height, fences at the <u>rear</u> or <u>side</u> of a dwelling may be up to 6 feet in height, and fences that run <u>parallel to streets</u> are permitted up to 3 ½ feet in height. - **New Area Code: 445** A new area code was added to the Philadelphia area to expand the supply of available numbers. It will coexist with 215 and 267 area codes. The new area code will ONLY be used for new service requests, additional lines or if you move. Everything else remains the same. No change to your existing area code, phone number or how you dial calls.
- "Geator with the Heater", Jerry Blavat, will DJ a dance at Maternity B.V.M. Saturday, April 7th. Cost is \$30, \$35 at the door, and will earn you dinner and soft drinks. Beer and wine will be sold separately. All ages come out to a Jerry Blavat dance.
- Homeless Veteran Heroes 7th District hosts a can goods collection to benefit our veterans at Mission BBQ, 11000 Roosevelt Blvd, Saturday, April 21, 11 am to 3:30 pm
- **7**th **District Captain Michael Gormley** has been promoted to the rank of Inspector and will be leaving Bustleton & Bowler. The GBCL would like to congratulate him on his advancement and thank him for his years of involvement with the Bustleton community. We would also like to welcome the return of **Captain Robert Ritchie** as the incoming Commanding Officer of the 7th and look forward to working with him.
- **Krewstown Road Festival Sunday, June 3, 2018** Last year's Festival and road closure was a first-time event, and such a success, organizers are doing it again. Mark your calendar.

 meeting. Nominations can be submitted at the April meeting.
- **Police Service Area 2 (PSA-2) Meeting**: Next Meeting April 9th,7 PM, Randi's Restaurant, Grant Plaza shopping center. The PSA meetings are the forum for having one-on-one conversations with a representative from the 7th Police District.
- **Friends of Pennypack Park** Nest meeting Thursday April 19th, 7:30 PM at Deer Meadows Residence on Roosevelt Boulevard north of Holme Avenue.
- **New Medicare Cards and SCAM** Starting 4/1/18, Medicare will be replacing current Medicare cards with new alphanumeric ID numbers. Beware of SCAMS requesting any personal information related to the change. Medicare never calls and does all communication by mail.

Zoning

- Red Lion Rd/Island Green After years of speculation on its future use, the 136-acre parcel
 of the former Budd Company was recently sold to the Commercial Development Corp. of St.
 Louis who has plans to build a warehouse center, consisting of three large buildings. Current
 plan drawings show two entrances on Red Lion Rd. and one on Sandmeyer Lane.
 The GBCL just learned of the project and looks forward to learning more from city officials
 regarding the impact on the surrounding community and what planning is being considered.
 The GBCL will pass on information to residents as it is received.
- Medical Marijuana Dispensary, 8900 Krewstown Rd. As reported earlier, Holistic Pharma confirmed that they are moving forward with opening their business on Krewstown Road. Permits have recently been secured to begin the interior renovation so building activity will soon be visible. The opening date is uncertain but was estimated to be in the June/July period. In February of 2017 the GBCL was first contacted by Holistic Pharma regarding their plans. In July of 2017 the GBCL hosted a community discussion and heard a presentation on the newly legal medical treatment by Dr. Charles Pollack from Thomas Jefferson University, and a Q & A session with Holistic Pharma. Updates will be provided as they're received.
- **1926 Grant Avenue** A project presentation and <u>VOTE</u> will take place at the <u>April 25</u> membership meeting on a USE variance request for a Religious Assembly. The proposed use as a religious assembly is prohibited in the CA-2 zoning district and requires a variance.
