- Pennypack Environmental Center 8600 Verree Rd. New Year's Fitness Hike Start the New Year off right and hit the trails instead while taking in some beautiful scenery. Wednesday, January 2, 2019 at 10 AM 12 PM. Open House Saturday, January 5, 2019 at 10 AM 1 PM. Cold Winters Night Hike Tuesday, January 22, 2019 at 7 PM 9 PM. Take a Full Moon hike through the nature sanctuary and discover what's going on in the woods this winter season. This program is geared towards adults, but children are welcome.

- Remove Illegal Advertisements Help keep Bustleton beautiful and free of litter by helping our cleanup army remove illegal curb/lawn sign advertisements. You see the advertisements nailed to telephone poles and stuck in the ground along the road. The signs are illegal, and unsightly.
- **Police Service Area 2 (PSA-2) Meeting:** Monday, January 14, 7 PM, Randi's Restaurant, Grant Plaza. Meetings are the forum for one-on-one conversation with a rep from the 7th District.

• Holiday Fire Safety Tips. The holiday season is one of the most dangerous times of the year for household fires, so take note of these areas to reduce your risk. Cooking is the top cause of holiday fires. The most common culprit is food that's left unattended. Make sure to keep a kitchen fire extinguisher that's rated for all types of fires, and check that smoke detectors are working. Candles. To reduce the danger, maintain about a foot of space between the candle and anything that can burn. Never leave flames unattended. Before bed, make sure all candles are blown out. Christmas Trees. It takes less than 30 seconds for a dry tree to engulf a room in flames. To minimize risk, buy a fresh tree with intact needles, get a fresh cut on the trunk, and water it every day. One of every four home Christmas tree fires is caused by electrical problems. Inspect light strings and throw out any with frayed or cracked wires or broken sockets. Extension cords should be in good condition and rated for indoor or outdoor use. Fires caused by children playing goes up significantly during the holidays. Keep matches and lighters out of kids' reach. Maintain a clean chimney and screen a fireplace to prevent embers from popping out onto the floor or carpet, and never use flammable liquids to start a fire in the fireplace. Only burn seasoned wood, and no wrapping paper.

## **Zoning - Update**

• **1922 Kohl St.** – ZBA hearing Dec. 19, 9:30 am. Outcome unknown at this time. Applicant requested a variance for the erection of a two-family dwelling, with garages and two front yard, surface parking spaces. Both two-family dwellings and surface parking spaces are prohibited in this RSD-3 Zoning District. The GBCL will announce the hearing results when known.

## **Zoning - Future Presentations:**

- **8828 E Roosevelt Boulevard** Owner has submitted a zoning application to legalize an existing two-family dwelling in an existing single-family zoned dwelling. Dates have not been set for a presentation to membership or for the ZBA hearing. When the GBCL is notified of a hearing date, the presentation date will be set; most likely at the January 23 membership meeting.
- **1819-25 Gregg St**, (Grand Champion Stables) While still early in the process, the owner's attorney has informed the GBCL that his client intends to file for a zoning permit to build 10 single homes on a private drive. The owner of the parcel met with neighbors back in August to hear their concerns and preferences. The GBCL will monitor the permit application process and announce the date of any project presentations when known.
