Bits and Pieces

- 1 Red Lion Rd./Budd Plant Update As mentioned in our February 6 update letter, UPS confirmed with the GBCL that they will be constructing a 1 million sq. ft. warehouse on the 138-acre parcel. Work on the warehouse could be started by the end of 2020, probably early 2021, and completed in 2022. There is a possibility that the project could be subject to the city's non-binding, Civic Design Review, which includes community input and comments. The mountain of dirt that currently exists on the site will be added to in the coming weeks and will eventually be spread across the entire parcel. Building plans, traffic studies, environmental issues, potential roadwork, are all topics that UPS stated would be addressed during a series of upcoming community outreach meetings. With some facts now confirmed, the GBCL continues to hold the position that the parcels use as a mammoth shipping distribution center, in the heart of a residential area, will create numerous unsafe traffic conditions and will have a damaging effect on businesses and resident's quality of life throughout our area. The GBCL looks forward to hearing additional project details at the upcoming UPS meetings. Dates of any meeting will be announced in the Bustleton/Somerton/Lower Moreland community once they are secured.

- Sense-of-Body PRESESENTATION: 9800 Bustleton/Fulmer St. Typically, zoning variance applicants are required to present their project to the local community organization as part of their application process. A sense-of-body presentation is an unofficial, non-binding presentation that the GBCL allows a developer to conduct to get a sense of what the community would support or oppose, before any unnecessary expenses are incurred. In this case, a local builder is considering a townhouse project on Fulmer Street and wants to hear community feedback before moving forward with any plans. A Special Exception is required for a use that is allowed, but only after the applicant has demonstrated that the use does not have any detrimental impact on the surrounding neighborhood.
