Bits and Pieces

Coronavirus in Bustleton – While Bustleton is not one of the more densely populated sections of the city, almost half of the residents tested in 19115 returned positive results of the virus. Bustleton/19115 has consistently been at the top of the list of city neighborhoods. (See <u>Results by Zip Code</u> link below) The GBCL inquired about the statistics and communicated directly with **Dr. Thomas Farley, Health Commissioner, Philadelphia Department of Health**. Dr. Farley stated that they "...honestly don't know why some zip codes have higher rates than others. It may be random – where the virus happened to land first." Testing supplies have been lacking in parts of the city and that it could also be that more people have been tested in Bustleton than in other zip codes. For whatever the reason for the high positive test results, <u>Bustleton residents need to pay extra attention to the precautionary directives of our medical experts</u>. **Cancellations**. Nearly everything that the GBCL would normally be addressing at this time of year is either postponed or cancelled. Monthly membership meetings, Phillies opener, Neighborhood Spring Clean-Ups, PSA-2 meetings, Zoning presentation and hearings, BVM Carnival, Bustleton Bengals summer season, Pennypack Environmental Center events. We will keep you informed as to which, and when these events will take place.

PA Opening - Gov. Wolf extended the state's stay-at-home order from April 30 to May 8, and as a "target date" to begin opening parts of the state's economy. The process will be slow and gradual and may not initially include densely populated areas like Philadelphia. All construction sites will also reopen May 1, as long as they adhere to all safety precautions.

• UPS at 1 Red Lion Rd.: Update – The GBCL spoke with the owner of the Red Lion Rd. parcel this week, CDC. They stated that they will continue to respond to any questions related to the Plan document sent to us March 31st. The NE Times ran article on the plans soon after they were sent: <u>https://northeasttimes.com/2020/04/07/more-details-about-ups-warehouse/</u> CDC sent their first set of responses to our initial questions which are posted on our website, and are included with the mailing of this newsletter. The GBCL continues to collect questions that will be consolidated and sent to CDC. CDC stated that the results of the Traffic Study they had conducted have been sent to city traffic engineers and PennDOT for comment. PennDOT has returned some comments to them and continues their review, while the city has yet to provide any feedback. CDC also stated that they are committed to hold in-person meetings with the community once conditions allow. While it's entirely understandable that most of us are distracted with the challenges and inconveniences the coronavirus crisis has brought us, please continue to call or write the GBCL with any questions or comments you have on the project.

As we have stated before, while we're grateful to finally be receiving some details on the project after two years of complete silence from our city and state elected officials, we haven't seen anything in the plans that changes our mind that a 24/7, massive package-delivery distribution warehouse, operating out of a residential neighborhood is anything but a colossal mistake. The risk to pedestrians, bicyclists, kids in school crossing lanes will increase dramatically with the addition of an army of delivery trucks rushing to their stops, 24 hours a day, 7 days a week, on roads that are already overly congested.

The addition of hundreds of delivery trucks driving through our neighborhoods 24/7 comes at a time when <u>pedestrian deaths</u> are on the rise in Philadelphia. Seventeen people were killed by motor vehicles while walking on Philadelphia streets in just the first three months of 2020, and conditions are particularly dangerous in the northeast. As mentioned in earlier updates, CDC and UPS confirmed with the GBCL that work on the 1 million sq. ft., quarter-mile long warehouse will begin by the end of 2020 or early 2021, and be completed in 2022. The mountain of dirt that currently exists on the site will be added to in the coming months and will eventually be spread across the entire parcel.

The Bustleton/Somerton/Lower Moreland communities wait to receive the results of the traffic study and other additional project details. Eventually an in-person community meeting will take place for us to hear a complete project summary in one session. Until that time, we will continue to share details as they arrive and prepare a response. While the overwhelming majority of opinions expressed are in opposition to the massive warehouse, we sincerely do want to hear all opinions, regardless of the position.

- **Primary Election** Governor Wolf postponed the PA Primary to **June 2, 2020**, and since no one knows for certain what the COVID-19 crisis will look like on June 2, it's safe to assume that voting by mail is the safest option through the states **'Stay Safe, Vote from Home'** mail-in program. - Census 2020 If you didn't submit your responses to the online Census questionnaire, you
 most likely recently received one in the mail. Using your given 12-digit ID you will be asked to
 count everyone who lives in your home as of April 1. The census is a count of every person who
 lives in the U.S. and its territories. It happens every 10 years and the 2020 census marks the
 24th time that the United States has counted its population since 1790. You will not be asked
 for your Social Security number or bank/credit card information. You will also not be asked for
 money or for anything on behalf of a political party.
- GBCL Elections The GBCL normally accepts nominations for officers at the March membership meeting, votes in April, with the new officers beginning their term in May. Because of the cancellation of public meetings we will be extending the voting process for another month. Anyone interested in nominating a member can contact nomination chairman Tommy James at junie412@hotmail.com Executive Board officers hold one-year terms, May through April. To date no nominations have been received. A method for voting will be established after nominations have been received.

• Keeping Bustleton Beautiful with 311 - The Philly311 contact center is Philadelphia's customer service center for all non-emergency inquiries. To help keep Bustleton Beautiful any resident can submit a service request or report an issue, on any subject that reduces our areas quality of life. You can submit a request anonymously online or by simply dialing 311. Abandoned cars, construction complaints, L&I issues, unlicensed business complaint, or graffiti removal as exampled below on Verree Rd. and Walley Ave. and reported to 311 by the GBCL.





- Wine & Spirits The Pennsylvania Liquor Control Board plans to expand its curbside pickup program from the initial 175 stores selected to nearly all its stores on Monday, April 27. Stores will take orders by phone, paid for in advance by credit card, and will limit the order to no more than six bottles. Only one order will be accepted per caller, per store, per day. The GBCL has joined forces with the FOPP on many park cleanups over the years and they will surely be missed. While Parks & Recreation is responsible for maintaining the park, the litter pick up and trail maintenance you enjoy is usually the work of the FOPP. They are just a great bunch of local folks volunteering their time so we can enjoy the beauty of the park. An increase in outside activities brought on by the coronavirus has also brought a big increase in foot traffic throughout the park, and the damage and litter are piling up.
