 - PADOT will repave the road first, and notify Streets Dept. of the timeline. <u>NO start date provided yet</u>.
 - GBCL requested <u>bike lanes</u> to be included, as per Deputy Commissioner Richard Montanez instructions. He added that the bike lanes need to be approved by City Council and has forwarded our request to Councilman O'Neill's office.
 - Current two car lanes will be reduced to one lane, in each direction, with bike lanes once approved.
