 - 1. Make sure you lock your vehicles at night and leave nothing of value visible inside the vehicle.
 - 2. NEVER leave your car running unattended. Don't run back into the house or run into a store.
 - 3. Be sure to close all windows, at least on the 1st floor, locked & secured because it's an easy entry for burglars.

- No Large Commercial Vehicle Parking Allowed in Residential Neighborhoods. June 17, 2022 City Council passed Councilmember David Oh's bills targeting illegal dumping and illegal parking of large commercial vehicles in residential neighborhoods specifically trailers, semitrailers and auto carrier trailers. The legislation amends a section of the Philadelphia Code, "On-Street Parking of Boats, Motor Homes, Truck Campers. Such vehicles cannot be parked on any residential street, for any amount of time. It also establishes a \$300 civil penalty for vehicles that are illegally parking on residential streets and authorizes the immobilization and towing of vehicles that are illegally parked in residential neighborhoods without proper authorization.
- Welsh Road Lane Reduction UPDATE Pine down to Alburger, reduced to one lane, and possibly to Grant as a result of neighbor's input.
 - You'll first see PennDOT repave the road, then Streets Dept. will paint the lane lines. NO start date provided yet.
 - GBCL requested <u>bike lanes</u> to be included, as per Deputy Commissioner Richard Montanez instructions, which he stated needs to be approved by City Council. This request was confirmed received with Councilman O'Neill's office.
- Bustleton is Truly Multicultural Earlier this month, Baldi Middle
 School, on Verree Road with 1,500 Students, celebrated their cultural
 diversity with a Multicultural Night through student song, dance, poems,
 and cultural fashion show. Principal Luke Hostetter stated that 30
 different languages are spoken in the school. Proceeds from a raffle
 were donated to the Ukrainian Federation of America. Dance show was
 by Voloshky School in Jenkintown, which is heavily involved in local
 Ukrainian relief.

House Rentals

- Yes, you can rent out your house. A RENTAL LICENSE is required to rent housing units or properties to tenants. Rental licenses must be renewed annually.
 https://www.phila.gov/services/permits-violations-licenses/get-a-license/business-licenses/rental-and-property/get-a-rental-license/
- No license is needed if the unit is being occupied by a family member and no rent is collected. However, you need to submit an AFFIDATE OF NON-RENTAL.
- Complaints about rental homes can be submitted through 311.

- **Property Assessments. Higher Tax Bills are on their way** City of Philadelphia needed to delay new property assessments for <u>three years</u> due to operating and pandemic issues.
 - o Average assessments increased by **31%** for residential properties.
 - We'll receive notice of the new valuations by mail, by Sept. 1, 2022.
 - Deadline for filing an appeal is Oct. 3, 2022. NOTE the tight 1month appeal window.
 - Property owners can look up their new assessed values now for the new tax bills by entering your address at https://property.phila.gov/
 - Your RE tax will be due March 31, 2023.
 - Mayor Kenney and City Council signed off on a city budget last week which takes effect July 1 and included raising the homestead exemption for the property tax from \$45,000 to \$80,000. It also included funding for programs that help lowincome families and seniors stay in their homes.

• Proposed UPS Warehouse for 1 Red Lion Road

Four years since the announcement of the project. Plans show a third-of-a-mile long, multi-story high warehouse with 500 truck loading bays.
