 - Christmas trees are extremely flammable. Look for a fresh, newly cut one. Cut two inches from the bottom of the stump to help it better absorb water. Check the level of water in the stand every day to make sure the tree remains hydrated. As a general rule, keep the tree three feet from anything that could be considered flammable.
 - Make sure that your Hanukkah menorah is at least three feet from anything flammable.
 - Check all string light wires for wear.
 - Make sure that every floor of your house has a working <u>smoke alarm</u>.
 If an alarm goes off, everybody in the house needs to exit immediately. Have an exit plan and practice it.

Holiday Health Tips from Philadelphia Department of Public Health

Tripledemic: RSV (respiratory syncytial virus), flu and Covid-19. While all three viruses are present now, they aren't each peaking at the same time. COVID-19 no longer represents a health emergency for people who are vaccinated.

- o Get your <u>flu shot</u> and <u>COVID booster</u>.
- Wear a mask in stores and on public transit
- See vulnerable loved ones first before attending large gatherings
- Space out gatherings. Omicron has a relatively short incubation period.
- Improve the <u>ventilation</u> in your home and reduce the virus particles. Open the windows occasionally.
- <u>Test</u> yourself for COVID especially before seeing elderly relatives or someone with a weakened immune system.

1. 9311 Voits Lane, ZBA Hearing 12/14/22, 9:30 AM – Side Deck. Initial presentation made at October membership meeting. After hearing objections, Applicant stated he would take the deck down, or return with revised plans. NO vote was taken. Architect recently stated he is not certain of Applicants decision. GBCL will notify ZBA of status.

Whatever happened to...? (cont.)

- 2. 2050 Welsh, ZBA Hearing 12/14/22, 9:30 AM. Angelic Home Care & Training operating in Residential district.

 Commercial business continues to operate unlicensed in a residential zoned block. June '22 presentation to GBCL membership ended with a unanimous vote to OPPOSE.

 Applicant postponed their August ZBA hearing and the GBCL has not received any stated revisions. GBCL will notify ZBA of status. Contact 311 today to report Unlicensed Business Complaint.
- 3. **9981 Verree** Beit Harambam Congregation Applicant formally withdrew zoning Appeal for fence height in front yard setback, and stated height and setback violations will be corrected.

There is not a similar facility of this size anywhere, that is located in a residential area, 2 miles from a major highway.



- Over 4,600 additional vehicles on Red Lion Rd. PER DAY.
- Over 1,000 of the 4,600 vehicles will be large tractor-trailers.
- No roads are being added.
- No roads are being widened.
- The warehouse building would be a third-of-a-mile long.
- Multi-stories high
- 500 truck loading bays
- Operating 24 hours a day, 7 days a week

UPS Warehouse, continued.

For the past four years, the Bustleton / Somerton / Lower Moreland communities have worked to stop the damage this project would inflict and intend to continue the opposition.

This is the biggest threat our community has ever encountered in the GBCL's 70-year existence.

The GBCL and Sandmeyer Lane businesses are appealing the zoning and building permits granted for the project. Both groups are appealing Philadelphia Court denials with the PA Commonwealth Courts.
