We have existed in Bustleton for over 70 years. We work to preserve the best in Bustleton and assure any future development is an improvement to our community.

We interact with the 7th Police District.

We represent Bustleton at Zoning Board of Adjustment (ZBA) hearings.

- The GBCL and its Executive Board officers individually received Court Summons. Sandmeyer Steal Company also received Court Summons.
- A Summons is the first official notice of a lawsuit a defendant receives to notify him or her that he or she is being sued. An associated <u>Complaint</u>, that describes the grievance, has not been received.
- SLAPP Suit (Strategic Lawsuits Against Public Participation) A term for the kind of lawsuit used by deep-pocketed interests to intimidate and silence opponents by taking them through the courts.

- GBCL holds General Liability, and Directors and Officers insurance.

- 1 Red Lion Road is a Keystone Opportunity Zone, **KOZ**, parcel.

## UPS Sorting and Distribution Warehouse Plan:

- Over 4,600 additional vehicles on Red Lion Rd. PER DAY.
- Over 1,000 of the 4,600 vehicles will be large tractor-trailers.
- No roads are being added.
- No roads are being widened.
  - The warehouse building would be a third-of-a-mile long.
  - Multi-stories high
  - 500 truck loading bays
  - Operating 24 hours a day, 7 days a week

For the past four years, the Bustleton / Somerton / Lower Moreland communities have worked to stop the damage this project would inflict and <u>intend to continue the opposition</u>.

This is the <u>biggest threat our community</u> has ever encountered in the GBCL's 70-year existence.

The GBCL and Sandmeyer Lane businesses are appealing the zoning and building permits granted for the project. Both groups are appealing Philadelphia Court denials with the PA Commonwealth Courts.

The Bustleton / Somerton / Lower Moreland <u>residents</u> and <u>businesses</u> **OPPOSE the SIZE/SCALE** of the operation.

- 9800 Bustleton Ave Parcel B /1719 Fulmer Townhomes.
  - December presentation ended with 34 to 12 votes to OPPOSE.
  - o 2<sup>nd</sup> Civic Design Review Presentation: Date TBD
  - o January 11 ZBA Hearing was CONTINUED. New date TBD
  - Application is for: The erection of new TOWNHOME DEVEOPMENT including thirteen (13) detached structures, with one hundred-thirty (130) accessory parking spaces and twenty-four (24) bicycle spaces. For use as multi-Family household living sixty-five (65) dwelling units.
  - Reason for need of a Variance and ZBA Hearing: The proposed use, multi-family household living, is expressly prohibited in the current I-2 industrial zoning district.
