

 PRESENTATION – "Complete Streets" - <u>Andrew Simpson</u>, <u>Yihong Hu</u> - OTIS, Office of Transportation, Infrastructure, and Sustainability – Complete Streets program works to ensure safe transportation options for all Philadelphians, whether they walk, bike, drive, or ride transit, and represents best practices in street design.

### **UPS Warehouse UPDATE**

Community opposition continues to the proposed 1.1 Million square foot warehouse.



- The GBCL invested considerable time and resources investigating the suitability of the massive sorting and distribution complex. The decision made to Appeal the zoning was thoughtful and justified.
- After 70 years in existence the GBCL is now being sued by the UPS warehouse developer.
- GBCL is very grateful for the citywide support and assistance that helped secure insurance coverage and allowed us to continue serving Bustleton community.

# Legal RECAP

• GBCL is involved in two ongoing proceedings.

# 1. Zoning Appeal in PA Commonwealth Court.

After being denied the opportunity to present a case in Phila. court, GBCL appealed to the state asking the court to send the case back to the ZBA and allow us to present our evidence. GBCL is exercising its right to appeal and will continue to work through the law and the legal process. A PA Appeal hearing in 2024 has yet to be scheduled.

### 2. UPS warehouse developer suing GBCL and Officers.

 GBCL <u>Defense</u> Attorney continues preparing case.
 GBCL believes UPS developer lawsuit is without merit and will aggressively defend against it. We are confident the facts and law are in our favor.

The GBCL was very instrumental in the introduction of a bill that would protects RCO's from developer lawsuits. Inquirer 11/14/23 – <u>City Council President Darrell</u> <u>Clarke introduces legislation to deter so-called SLAPP</u> <u>suits against RCO's</u>. If his proposal passes before the end of this term, it would be placed on the ballot during the primaries next April for voters to decide on. <u>ARTICLE</u> What can you do to help our community opposition?

# **Tonight's Civic Design Review PRESENTATION:**

#### 9903 Bustleton Ave, Sloane Honda

Even when a development project doesn't require any variances, some projects require a **Civic Design Review**, or CDR. Developers present their projects to the local RCO before they present them to City Planning Commission.

The developer and the RCO then appear at the CDR. At the RCO presentation residents get to provide input on projects that will affect their community, and developers get feedback on their plans from a fresh set of eyes. Any input provided is not mandatory instructions for the developer.
