- Pennsylvania 2023 Property Tax/Rent Rebate
   STILL OPEN, 888-222-9190. Applications for 2023
   Rebates are due by December 31, 2024. The program is one of five programs supported by the Pennsylvania Lottery. Based on your income, this program provides a rebate ranging from \$380 to \$1,000 to eligible older adults and people with disabilities age 18 and older. Rebates will begin to be issued in July.   - 65 and older Widows and widowers 50 and older
  - People with disabilities 18 and older
  - Household income must be \$45,000 or less annually.

• SLAPP suit Bill - Voters approved ballot measure giving community groups legal protection. Providing City Indemnification & Defense for RCOs and help RCO's fulfill their obligation under the zoning code. After being signed by the Mayor, question will appear again at the November 5 General Election.

SLAPP suit Bill gained momentum in part because of the lawsuit brought against the GBCL by the UPS warehouse developer.

# **ZONING – Proposed UPS Warehouse – 1 Red Lion Rd.**



The proposed UPS warehouse is the most damaging development our community has ever faced.

 Our community is asking our elected officials to reexamine the project plans, and recognize the impact.

They could then have an informed discussion with the owner regarding the impact on the community and the parcel's future use.

 Despite being sued by the UPS developer, the GBCL looks forward to when we'll finally be allowed to put on our case and validate the community's opposition.

# **UPS Warehouse Legal Status**

GBCL is involved in two (2) ongoing proceedings.

#### 1. Zoning Appeal in PA Commonwealth Court.

- Our Appeal in Commonwealth Court is <u>not</u> a determination of the critical <u>zoning</u> issues.
- The Commonwealth Appeal is a <u>procedural</u> request for "due process" permitting us to put on our full case, which has never been allowed to take place.

# 2. <u>UPS developer Suing GBCL and its Officers.</u>

- Relteva Complaint: "GBCL and Sandmeyer have submitted frivolous appeals of both the zoning and building permits lawfully issued to Relteva that have absolutely no legal merit and which were submitted solely for the purpose of <u>delay</u>, <u>harassment</u> and <u>thwarting the development</u> of the Property."
- GBCL believes UPS developer lawsuit is without merit and will aggressively defend against it. We are confident the facts and law are in our favor.
